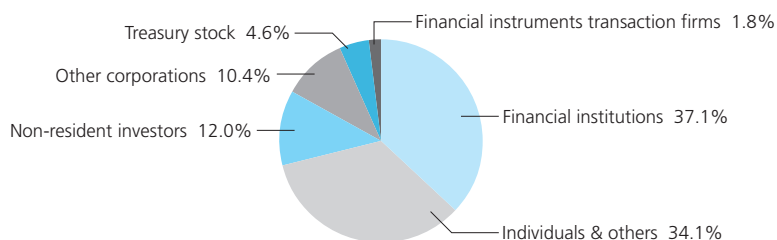

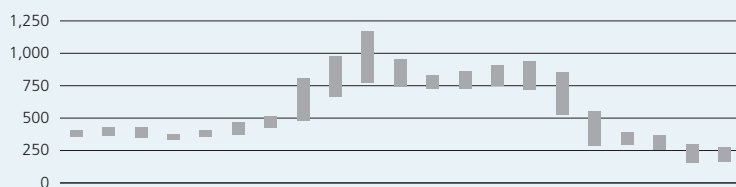

Share Distribution by type of Shareholder

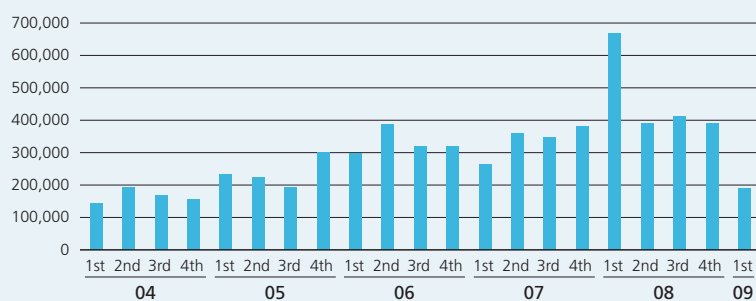


(As of March 31, 2009)
